Itinerary

Day 01: Arrive Cochin to Munnar (140 Kms / 5 Hrs)

Upon arrival at Cochin airport/ railway station, meet with our representative and transfer you to Munnar.. Munnar is located at the confluence of 03 rivers as the very name signifies. The tea plantations and picturesque towns make Munnar a popular hill station in South India. Enroute visit Cheyyapra waterfalls, Valara waterfalls, Attukadu waterfalls, Spice plantations etc. On your arrival at Munnar you will be transferred to the hotel. . Evening at leisure. Overnight stay in Munnar.

Day 02: Munnar

In the morning after breakfast, start the sightseeing of Munnar visiting the tea plantations, Tea Museum, the Eravikulam National park home of the endangered Niligiri Thar (Ibex), followed by visit to the Mattupetty dam, the the Kundala Lake and other scenic spots. Overnight stay at the Hotel.

Day 03: Munnar to Kodaikanal (160 Kms / 4 Hrs)

Morning after breakfast transfer to Kodaikanal. With its name meaning the 'The Gift of the Forests', Kodaikanal is a hill station located in the eastward hills of the Western Ghats in the state of Tamil Nadu.. Arrive Kodaikanal and check-in at Hotel. Rest of the day is at leisure. Overnight stay in Kodaikanal.

Day 04 : Kodaikanal

Morning after breakfast proceed for the sightseeing trip of Kodaikanal which includes the kodai lake, coaker's walk, bryant park, green valley view, pillar rocks and kurinji andavar temple. Overnight stay in kodaikanal.

Day 05: Kodaikanal to Ooty (260 Kms / 7 Hrs)

Morning after breakfast check out from the hotel/Resort and proceed to Ooty. Ooty, also known as Udhagamandalam, is a hill station in the state of Tamil Nadu, in southern India. Check-in to the hotel on arrival and relax for a while. Then proceed for the evening sightseeing of the Botanical Garden Overnight stay in ooty.

Day 06: Ooty

Morning after breakfast proceed for the sightseeing trip of Ooty, which includes the botanical gardens, the Dodabetta peak, Ooty lake, the rose garden, lamb's rock etc. Overnight stay in ooty.

Day 07 : Ooty – Coimbatore (100 Kms / 02 Hrs).

Morning after breakfast check out from the hotel and our representative will drop you at

Coimbatore airport/ railway station for onwards destination.
