Itinerary

Day 01: Arrive Chennai | Chennai – Tirupati (170 Kms / 4 Hrs)

Upon arrival at Chennai airport/ railway station our representative will help you take a transfer to Tirupati. Enroute visit the famous Srikalahasti Temple.. Seek blessings of Lord Shiva and after Darshan, head forward to Tirupati. Evening at leisure. Overnight stay in Tirupati.

Day 02: Tirupati

In the morning after breakfast head towards Tirumala. Tirumala is located near Tirupati in the Chittoor district of Andhra Pradesh. After Darshan, visit the famous temples of Tirumala, including Padmavathi Temple and Sri Kalyana Venkateswaraswami temple. Also visit Kapila Theertham a temple dedicated to Lord Shiva. Overnight stay in Tirupati.

Day 03: Tirupati to Pondicherry (260 Kms / 6 Hrs)

Morning after breakfast you will be transferred to Pondicherry. Pondicherry is a blend of spiritual aura, French colonial heritage, Tamil culture, virgin beaches and the cosmopolitan flair of many nationalities in a small but varied city.
